## CONTRACT CONDITIONS

1. **Joining** the Karate school is possible at **any time**. The course fees for the first payment period are due with the completed registration form. The course fees are due in advance and in full. They are also due for the full period even if the student drops out of the course.
2. The **duration of this contract** can be chosen either **yearly** (January through December) or **half-yearly** (January through June / July through December) per calendar year. Membership that begins between payment periods will be charged pro rata temporis.
3. Any **notice of termination** must be in written form and sent with registered mail **at least 30 days** before the chosen end date of a payment period (latest by 31<sup>st</sup> May or 30<sup>th</sup> November). The contract will be automatically extended for another payment period by default should the Karate school not receive a notice of termination. All due payments have to be paid as per value date of the notice of termination. If this condition is not fulfilled, the contract will be automatically extended for another payment period by default.
4. Certain **fees** are billed one time only. Yearly fees (e.g. licence tag) will be charged with for the current calendar year.
5. Registered students may participate in training at all dojo of Swiss Seishinkai Karate-Do and on all regular training sessions.
6. **Karate equipment** can be ordered from the Karate school. Other services such as belt test fees, belts, courses etc. are **not** included in the course costs.
7. The Karate school assumes **no liability** for loss or accident. The student has to ensure private insurance coverage (theft, accident, third party liability). The Karate school cannot be held liable for any accidents during the training hours, damage caused or any missing objects.
8. Students and relatives of students are only allowed to **take photos** or make **movies** if the trainer has **explicitly** allowed this. It may be that trainers will take photos or make movies during trainings, courses and belt tests. Normally, these photos and movies will be available to the students. With my signature I accept that selected photos will be published on the homepage and/or on Facebook of the Karate school. I accept that photos will be published in local newspapers and movies may be shown on TV.
9. There is no training during the local school holidays and on official public holidays. The Karate school may close the school or reduce the training hours during regional, cantonal or public holidays without any further compensation. If a training will be cancelled by the landlord or due to Force majeure (training facilities not usable, pandemic etc.), students cannot claim these lessons and there is no right for reimbursement. The Karate school has the right to make short term changes of place and dates of training as needed. The house rules of the Karate school and the landlords are an integrated part of this contract and must be followed by all participants.
10. **Interruptions** to the automatic billing process are only possible in case of illness, accident, military service or civil service. If a student cannot participate in training for a longer period (accident and illness longer than one month) the student is required to inform the Karate school within one week and to provide a medical certificate. Military service or civil service that takes longer than one month needs to be reported in written form at least two months prior to start (with marching orders). Late requests will be categorically rejected. Reimbursement for missed training is not possible. Any credit can only be applied to a later payment period. Holidays as per training plan cannot be included in the calculation in neither of these cases.
11. **Reminder mechanism and enforcement**
  - First reminder, B-Post mail, free of charge, payment deadline 10 days.
  - Second reminder, registered mail, charges CHF 15.00, payment deadline 10 days.
  - A charge of CHF 15.00 is being billed for every further communication via registered mail.
  - Additional handling charges of CHF 50.00 are due in case of an enforcement.
12. The **legal representative** of an underage course participant is solely liable without limitation. Other agreements are only valid if they are confirmed in writing. The Swiss Law of Obligations applies for any other issue. Court of jurisdiction applies for any possible conflicts is Uster.
