CONTRACT CONDITIONS

1. Joining the Karate school is possible at any time. The course fees for the first payment period are due with the completed registration form. The course fees will be billed automatically after the initial period and are due in advance and in full. They are also due even if the student drops out of the course.
2. The **duration of this contract** can be either yearly (January through December) or half-yearly (January through June / July through December) per calendar year. Membership that begins between payment periods will be charged pro rata temporis.
3. Any **notice of termination** must be in written form and sent with registered mail at least 30 days before the chosen end date of a payment period (latest by 31st May or 30th November). Should we not receive a notice of termination, the contract will be automatically extended for another payment period by default.
4. Interruption to the automatic billing process is only possible in case of illness, accident or military service (of three weeks or more, by advance notification). If a student cannot participate in training for longer than one week, the student is required to inform the Karate school. Late requests will be categorically rejected. Reimbursement for missed training is not possible. Any credit can be applied to a later payment period.
5. The **fees** for the registration and the SKF passport are billed one time only. The student is asked to attach a passport sized photo to the registration form. The yearly SKF licence tag will be charged with for the current calendar year and will be renewed each January.
6. This Karate school is a member of the „**Swiss Karate Federation**“ (SKF) and has to follow their rules and regulations. The fees for licence stamps are fixed by SKF. Swiss Seishinkai Karate-Do has no influence on these fees. Prices are subject to change. Belt tests take place twice a year (spring / autumn) and will be communicated in advance. They are in accordance with the rules and regulations of SKF.
7. The Karate school may close the school or reduce the training hours during **regional, cantonal or public holidays** without any further notification. Registered students may participate in training at all locations. The school has the right to make short term changes of place and dates of training as needed. The house rules of the Karate school are an integrated part of this contract and must be followed by all participants.
8. **Karate equipment** can be ordered from the school. Other services such as belt test fees, belts, courses etc. are **not** included in the course costs.
9. The Karate school takes **no liability** for loss or accident. The student has to ensure private insurance coverage (theft, accident, third party liability). The Karate school cannot be held liable for any accidents during the training hours, damage caused or any missing objects.
10. The **legal representative** of an underage course participant is solely liable without limitation. Other agreements are only valid if they are confirmed in writing. The „Schweizerische Obligationsrecht“ applies for any other issue. Court of jurisdiction applies for any possible conflicts.
